**Filing Deadline:** Self-nomination forms must be completed and turned in to the District's Designated Election Official (DEO) no later than **Friday February 24, 2023 at 5:00pm.** Insufficient self-nomination forms submitted to the DEO prior to the filing deadline must be cured by no later than 3:00pm on Friday February 24, 2023.

**Note:** An eligible elector may submit a letter to the DEO in lieu of this form. However, the letter must contain the same information as provided in this form.

**Write-in Candidates:** An eligible elector who desires to be a write-in candidate<sup>1</sup> will for the board election must file an affidavit of intent stating that he or she desires the office and is qualified to assume his/her duties if elected. The affidavit must be submitted to the DEO **no later than Monday February 27, 2023 at 5:00pm.**

Self-nomination forms submitted to the District are public records (1-4-504 CRS).
